Nearly \$375,000 in capital improvements

In 2010 we completed a number of capital projects including the addition of operating room high definition video towers which allows our surgeons to view their procedures on state of the art equipment. We were also able to upgrade the look of the front entrance inside our hospital for our patients and visitors to enjoy. The hospital added pharmacy towers in different patient care departments to improve medication distribution safety for our patients. We have much planned for 2011 with a total patient care information system conversion which allow the hospital to meet the meaningful use criteria that is required for health care reform.

In fact, we invested \$374,105 in our facilities last year which, in addition to the above, included technology replacement, information technology additions/updates, and important facility upkeep and maintenance.

These additions and renovations will help Bourbon Community Hospital continue to grow and be better able to serve our constituents.

Contributing to our local tax base

Last year, Bourbon Community Hospital paid \$576,844 in taxes which helped to support our city, county and state. This included sales taxes as well as property taxes. These dollars help support local schools, the development of roads, the recruitment of business and industry, and other vital community services.

Helping those in need

Bourbon Community Hospital provided more than \$27.4 million in uncompensated care last year, which included the amounts not covered by Medicare and Medicaid. This amount includes more than \$3.4 million for charity care and bad debts incurred as we served many people without the financial resources to pay for basic health services.

Adding new physicians

During the past year, Bourbon Community Hospital added 32 new physicians to our highly respected medical staff, including specialists in dentistry, emergency medicine, hospital medicine (hospitalist), radiology and otolaryngology.

"Charity and other uncompensated care" includes the amounts not covered by Medicare and Medicaid as well as charity care and bad debts. "Physician recruitment costs" include recruitment costs and support of new physicians' initial practice establishment in the community. Payroll includes consolidated salaries, wages, benefits and contract labor costs. "Capital investments" include facility expansions/renovations, equipment purchases, technology replacement, information technology additions/updates, and routine facility upkeep and maintenance.
